Comments:

1 to 5. Thick grease is on all surfaces of the kitchen creating a fire hazard. Grease has penetrated the equipment and is dripping from the roof down the side of the building. These issues have been brought to the attention of the property owner on several occasions. The equipment appears to be not working properly as noted today the applicant said that two burners do not work on the stove. The fire protection equipment is coated in grease and has not been serviced. Electrical outlets are coated in grease. The owner has been advised to not use these outlets and to have a professional service all electrical for possible hazards. The exhaust system does not appear to be NFPA 96 compliant and a letter from a professional stating that the system is compliant will be required.

6. Kitchen portable fire extinguisher service tag is expired. Annual service is required.

You are hereby notified that the above conditions shall be corrected **within 14 days**. Failure to correct the above noted violations could render the owner or occupier liable to penalties provided for under The District of North Vancouver Bylaws and/or regulations pursuant to the Fire Services Act.

Note: 2012 BC Fire Code Div C 2.2.1.1.(1) "Unless otherwise specified, the owner or the owner's authorized agent shall be responsible for carrying out the provisions of this code."
